## Fiscal Performance Report for January 2002

# Overall fiscal performance - budgetary and treasury operations

Total expenditures (budgetary and treasury) for the month of January 2002 amounted to LL 786 billion, while total revenues (budgetary and treasury) amounted to LL 475 billion. Hence, total deficit for the month amounted to LL 312 billion, equivalent to 39.66% of total expenditures. The total primary surplus for the month amounted to LL 129 billion.

# **Budget operations**

On the budget execution front, budget expenditures during the month of January 2002 amounted to LL 581 billion and budget revenues amounted to LL 443 billion. The budget deficit for January 2002 amounted to LL 138 billion, equivalent to 23.81% of budget expenditures. In addition, a budget primary surplus of LL 302 billion was achieved during January.

# **Treasury operations**

As for treasury operations during the month of January 2002, they resulted in a deficit of LL 173 billion, equivalent to 84.63% of treasury expenditures.

### Note:

Budget revenues and expenditures are not equally distributed among the months of the year. Therefore, upon the execution of the budget, revenue and expenditure figures from both the budget and treasury accounts will differ among the months of the year and with it the deficit ratio and amount.
