Request for Expressions of Interest N0. 11

This invitation for expressions of interest follows the general procurement notice for this project that appeared in the Development Business on 05 January 2009.

The Ministry of Finance has received a grant from the International Development Agency (IDA), toward the cost of the Emergency Fiscal Management Reform Implementation Support Project and it intends to apply part of the proceeds of this grant to payments under the contract to be signed with individual consultants for the post of **INTERNATIONAL MACROECONOMIC ANALYSIS AND MODELING ADVISOR (Proc ref C1-IC-01)**.

The project includes five components. The first component supports strengthening macroeconomic programming and policy analysis in the Ministry of Finance. The second component provides assistance to improve the management of public expenditure. The third and fourth components provide advisory services to strengthen debt and aid management, respectively. The fifth component assists in the provision of targeted training connected to the other components of the project. The project extends until June 30, 2013.

The Ministry of Finance now invites eligible individual consultants to indicate their interest in providing the above services. Interested individual consultants must provide information indicating that they are qualified to perform the services. The expression of interest should be in the form of the CV template published on the web site with the terms of reference. The consultant should clearly state the position she/he is applying for in the top section of the CV.

Expressions of interest in the form of CV should be submitted by individual consultants. Once the short-list is finalized, interviews are expected to be conducted in order to finalize the selection process. The best qualified consultant for the above post will be invited to submit a financial proposal. Negotiations of the terms of the contract are expected to be conducted in July 2012. Interested eligible Consultants for the assignment may obtain further information from the Ministry of Finance at the address given below.

Consultants will be selected in accordance with Individual Consultant selection process and the procedures set out in the World Bank's *Guidelines: Selection and Employment of Consultants by World Bank Borrowers* (May 2004; revised October 1, 2006).
