

I. Treasury Transfers to EDL in August 2015

▶ *In August* 2015, treasury transfers to EDL reached 76.33 LL billion, as follows:

⇒ Reimbursement of KPC and Sonatrach 67.99 LL billion

⇒ Debt Service 8.35 LL billion

II. Treasury Transfers to EDL in 2015 in comparison with 2014

▶ Transfers to EDL in Jan-Aug 2015 were 1,028.01 LL billion lower than the Jan-Aug 2014 level

Transfers in Jan-Aug 2015 were 1,028.01 LL billion lower than the amount paid in Jan-Aug
2014, which stood at 2,214.93 LL billion. This was mainly a result of lower payments to KPC
and Sonatrach for fuel oil and gas oil purchases.

- Payments to the two oil suppliers in Jan-August 2015 were LL 1,025.05 billion lower than their level during Jan-Aug 2014.

The component "Reimbursement of KPC and Sonatrach Agreements" reached LL 1,161.05 billion in Jan-Aug 2015, down from LL 2,186.10 billion in Jan-Aug 2014. This 46.9 percent decrease was mainly driven by lower average prices of crude oil and lower quantity of fuel and gas oil purchases.

From a quantity-effect viewpoint:

- o % Change in Quantity of Fuel Oil imported: 14.54% ▼
- o % Change in Quantity of Gas Oil imported: 4.49% ▲



III. Contribution of EDL out of the total oil bill

▶ EDL contributed by 2.8 percent of the total oil bill in Jan-Aug 2015

From a total oil bill of LL 1,195 billion in Jan-Aug 2015, EDL contributed by 2.8 percent to the cost of gas oil and fuel oil purchase¹. This figure was at 2.0 percent during the same period of 2014, out of a higher bill of LL 2,230 billion. In nominal terms, EDL's contribution was lower in Jan-Aug 2015, amounting to LL33 billion, compared to LL 44 billion during the same period in 2014.



IV. Shares of "Transfers to EDL" out of Expenditures

▶ Transfers to EDL constituted 13.6 percent of primary expenditures in Jan-Aug 2015

With primary expenditures at LL 8,758 billion, the share of transfers to EDL reached 13.6 percent. This share was higher at 23.4% in Jan-Aug 2014.

¹ The Treasury transferred around LL 1,186.92 billion to cover EDL's deficit in Jan-Aug 2015. Out of this amount, around LL 1,161.05 billion represented the Treasury transfer to purchase gas oil and fuel oil (as shown in Table 2). However, the total oil bill for Jan-Aug 2015 amounted to LL 1,195 billion, which correspond to LL1,161.05 billion of Treasury transfers plus LL 33.45 billion of payments made by EDL.




Figure 2: Transfers to EDL out of primary expenditures (Jan-Aug 2014 – Jan-Aug 2015)
