

I. Treasury Transfers to EDL in January-July 2012

- ▶ *In July* 2012, treasury transfers to EDL reached LL 387 billion, as follows:
 - ⇒ Reimbursement of KPC and Sonatrach LL 367.9 billion
 - ⇒ Debt service LL 18.6 billion
- Between January and July 2012, treasury transfers to EDL reached LL 1,866 billion, as follows:

⇒ Reimbursement of KPC and Sonatrach LL 1,802.3 billion

⇒ Debt service LL 63.3 billion

II. Treasury Transfers to EDL in Jan-July 2012 vs. January-July 2011

Transfers to EDL between January and July 2012 were LL 721 billion higher than the amount paid during the same period in 2011

Transfers in January-July 2012 were LL 721 billion higher than the amount paid during the same period of 2011, which stood at LL 1,144 billion, as a result of the following two factors:

- \Rightarrow Increase in payments to KPC and Sonatrach for fuel oil and gas oil purchases, by LL 773 billion
- ⇒ Increase in debt service, by LL 3 billion

The above increases were partly offset by a decrease in natural gas purchases from EGAS, by LL 55 billion

Payments to the two oil suppliers in January-July 2012 were LL 773 billion higher than their level during the same period of 2011

The component "Reimbursement of KPC and Sonatrach Agreements" reached LL 1,802 billion in January-July 2012, up from LL 1,029 billion in January-July 2011. This 75 percent increase was mainly driven by higher international oil prices at the time when the gas oil and fuel oil shipments were imported.

- From a quantity-effect viewpoint: gas oil imported during May 2011-February 2012 (paid in January-July 2012) is 30% higher than the quantity imported between June 2010- Feb 2011 (paid in January-July 2011). In return, fuel oil quantities imported during July 2011 and January 2012 (paid in January-July 2012) increased by 5 percent, compared to July 2010 and January 2011 (paid in January-July 2011).
- From a price-effect viewpoint: the average oil price according to which the January-July 2012 payments were made is 35 percent higher than that pertaining to January-July 2011. This is due to the fact that 2012 payments reflect consumption over the period May 2011 and February 2012, where the weighted crude oil average prices were US\$ 111.4 /barrel. The January-July 2011 payments reflect consumption over the period June 2010-February 2011, where crude oil prices averaged US\$ 82.3/barrel.

III. Contribution of EDL out of the total oil bill

▶ EDL contributed 2.5 percent of the total oil bill in January-July 2012

With a total oil bill of LL 1,848 billion paid in January-July 2012¹, EDL contributed by 2.5 percent to repaying of KPC and Sonatrach. This figure was higher at 8.5 percent during the same period of 2011, out of a smaller bill of LL 1,185 billion. In nominal terms, EDL paid higher contribution in January-July 2011, amounting to LL 101 billion compared to LL 46 billion during the same period of this year. This represents a much lower contribution compared to that of 2010, which amounted to LL 131 billion or 11.4 percent out of an oil bill of LL 1,150 billion.




Figure 1: Contribution of EDL (Jan-July 2008 - Jan-July 2012)

¹ The Treasury transferred LL 1,866 billion to cover EDL's deficit in January-July 2012. Out of this amount, LL 1,802 billion represented the Treasury transfer to purchase gas and oil (as shown in Table 2). However, the total oil bill for January-July 2012 summed up to LL 1,848 billion which is constituted of LL 1,802 billion of treasury transfers "plus" 46 billion of transfers made by EDL.

IV. Share of "Transfers to EDL" out of Expenditures

▶ Transfers to EDL constituted 24.5 percent of primary expenditures in January-July 2012

With primary expenditures at LL 7,616 billion in January-July 2012, the share of transfers to cover EDL's oil bill reached 24.5 percent, registering the highest share in the last three years. The share of transfers out of primary expenditures was lower in January-July 2011, at 17.9 percent.




Figure 2: Transfers to EDL out of primary expenditures (Jan-Jul 2010 - Jan-Jul 2012)
