

## I. Introduction

Salaries, wages and related benefits payments, which mainly include the cost of basic salaries, indemnities and allowances, increased by LL 701 billion, from LL 2,920 billion in Jan-Oct 2011 to LL 3,621<sup>1</sup> billion in Jan-Oct 2012.

Out of that component, basic salaries reached LL 2,674 billion in Jan-Oct 2012, a LL 503 billion or 23 percent increase compared to LL 2,171 billion paid in the same period in 2011. This increase is mainly the result of the 2012 cost of living payments<sup>2</sup>. In details, during period Jan-Oct 2012, cost of living adjustment and various retroactive payments totaled LL 539 billion (out of LL 2,674 billion), much higher than the LL 206 billion (out of LL 2,171 billion) paid in the same period of 2011.

If cost of living adjustment and retroactive payments are excluded in both years, basic salaries would reach LL 1,965 billion in Jan-Oct 2011 compared to LL 2,135 billion in Jan-Oct 2012, an increase of 9 percent, partly due to additional recruitment of internal security agents and discrepancy in timing of payment to education personnel.

## II. Breakdown of Salaries, Wages, and Related Benefits

Salaries, wages and related benefits represent the largest component of total primary spending, accounting for 31 percent for Jan-Oct 2012, down from 32 percent for the corresponding period of 2011.

### III. Breakdown of Basic Salaries

#### III.A. Basic Salaries of Military Personnel

The 15 percent increase in basic salaries of military personnel is primarily attributed to cost of living and respective retroactive payment<sup>3</sup> which was started to be made in September 2012 and both amounted to LL 291 billion during Sep-Oct 2012.

The increase in basic salaries of military personnel was slightly offset by the lower payments relating to a one-off field service indemnity payment, which was made in February 2011 and amounted to LL 52 billion, along with the 1996-1998 retroactive<sup>4</sup> payments which was made in Jan-Oct 2011 for a total amount of LL 117 billion. The same payments reached nil and LL 33 billion respectively in Jan-Oct 2012.

Once the impact of cost of living adjustment and retroactive payments is removed, basic salaries of military personnel display an increase of LL 55 billion (4 percent).

#### III.B. Basic Salaries of Education Personnel

The 44 percent increase in basic salaries paid to the education personnel in Jan-Oct 2012 is mainly explained by the following:

- The one-off retroactive payment amounting to LL 21 billion<sup>5</sup> and LL 99 billion<sup>6</sup> respectively paid in January 2012 and October 2012 relating to the four exceptional echelons granted<sup>7</sup>

to primary and secondary teachers as well as to the second, third and fourth category of the education personnel in the Directorate General of Vocational and Technical Education.

- The cost of living adjustment and respective retroactive payments totaling LL 18 billion and paid in October 2012.

Once the impact of the retroactive payment and the cost of living adjustment is removed, basic salaries of education personnel display an increase of LL 92 billion (18 percent), mainly driven by the following:

- A LL 67 billion increase in payments made to contractual personnel at the Directorate General of Vocational and Technical education during the period Jan-Oct 2012, compared to nil during the same period of 2011. This increase is mainly attributed to a discrepancy in the timing of payments.
- A LL 16 billion increase in payments to primary, intermediate and secondary contractual increased mainly relating to a 37 percent increase in the number of secondary contractual teachers between the academic year 2010-2011 and 2011-2012.

### *III.C. Basic Salaries of Civilian Personnel*

The 25 percent rise in payments to the civilian personnel is partly due to the LL 16 billion payments of 2005-2009 foreign currency retroactive<sup>8</sup> in 2012 and the LL 26 billion cost of living adjustment, compared to nil in 2011.

From an administrative classification<sup>9</sup> perspective, the most notable increases during this period occurred in the following categories: (1) diplomats in Lebanese overseas missions, (2) diplomats in the Central Administration at the Ministry of Foreign Affairs, and (3) judges<sup>10</sup> category, which rose by LL 14 billion, LL 7 billion and LL 22 billion, respectively.

- The increase in payments to diplomats in Lebanese overseas missions is due to significant discrepancies in timing of payments of monthly salaries following the payment in Jan-Oct 2012 of LL 5 billion that were due in 2010 and the LL 9 billion foreign currency retroactive payments which were partially offset by a decrease in the 1996-1998 retroactive payments by LL 4 billion.

- The increase in payments to Lebanese Diplomats who are in residence at the Central Administration of the Ministry of Foreign Affairs in Beirut is due to the LL 7 billion payment in April 2012 of the foreign currency retroactive<sup>11</sup>.
- The rise of payment to all judges from LL 39 billion to LL 61 billion between Jan-Oct 2011 and Jan-Oct 2012 is mainly the result of the new salary and wage scale law<sup>12</sup> providing both civilian and religious judges with higher salaries.

It is worth noting that some of the 2012 basic salary payments to the civilian personnel were made through treasury advances<sup>13</sup>.

#### IV. Payments of Allowances

Allowances increased by LL 136 billion, from LL 376 billion in Jan-Oct 2011 to LL 512 billion in the comparable period of 2012, mainly as a result of higher payments to the Army (+LL 112 billion), the Internal Security Forces (+LL 13 billion) and the State Security Forces (+LL 6 billion). Behind the increase stands higher payments to education allowances (+LL 98 billion), hospitalization allowances (+LL 30 billion) and maternity and sickness allowances (+LL 6 billion).

#### V. Payments to the Civilian Servants' Cooperative

The item "other"<sup>14</sup>, which is mainly composed of payments to the Civilian Servants' Cooperative, witnessed a significant increase of LL 57 billion in Jan-Oct 2012. This is due to a cash management issue and discrepancy in timing of payment, as LL 61 billion<sup>15</sup> out of the LL 196 billion transfer made to Civilian Servants Cooperative in Jan-Oct 2012 were from the 2011 Budget Proposal allocation; this compares with a total transfer of LL 140 billion in Jan-Oct 2011.

#### VI. Payments to Customs

Payments to Customs witnessed an increase of LL 12 billion in Jan-Oct 2012 compared to the same period of 2011. This difference is primarily attributed to the payment of cost of living adjustment which amounted to LL 5 billion.
